FELONY - GROSS MISDEMEANOR FIRST APPEARANCE STATEMENT OF RIGHTS
TXOJ CAI THAUM NTSIB XAM THAWJ ZAUG HAIS TXOG ROOJ PLAUB LOJ NRAB-FELONY.

I understand: *Kuv to taub:*

1. I am charged with committing the offense(s) described in the complaint, citation, or ticket.
Kuv raug foob raws cov txhaum rau rau hauv daim ntawv foob los daim ntawv nplua no.
2. The possible sentence for each offense is as specified in the complaint, citation, or ticket.
Lub txim yuav hnyav npaum li cas raugtxhua txoj kev txhaum los yeej nyob hauv daim ntawv lawv foob los nplua.
3. I have the right to be represented by an attorney at all times, including police line-up or during police questioning.
Kuv muaj txoj cai kom tus neeg hais plaub pab kuv txhua lub sij hawm, thiab lub sij hawm thaum tub ceev xwm muab kuv mus sawv ua ib phiaj los thaum lawv nug kuv lus.
4. An attorney will be appointed to represent me if I cannot afford to pay for an attorney.
Lawv yuav muab ib tug tus neeg hais plaub los pab kuv yog hais tias kuv tsis muaj nyiaj txaus ntiav tus neeg hais plaub pab kuv.
5. I do not have to say anything about the case. I do not have to answer questions from anyone about the case.
Kuv tsis tag hais ib lo lus txog roojoj plaub no los tau. Kuv tsis tag teb ib tug neeg cov lus nug txog roojoj plaub no los tau.
6. Anything I say may be used against me.
Txhua yam kuv hais rau lawv, lawv yeej siv coj los ntxo tau kuv.
7. I can speak to an attorney before my next Court appearance, and I will be given enough time before my next Court date to obtain an attorney.
Kuv muaj txoj cai tham nrog tus neeg hais plaub ua ntej kuv nce xam los tau, thiab lawv yeej muab sij hawm rau kuv nrhiav neeg hais plaub rau kuv ua ntej kuv nce xam.
8. I can have a jury trial or a trial by a judge without a jury.
Kuv muaj txoj cai xaiv ib pab neeg los txiav plaub rau kuv los kom ib tug neeg txiav txim mam li txiav txim rau kuv xwb los yeej tau.
9. I can tell the judge today what I think should be done about bail or my release from custody.

10. I can be charged with a criminal offense if I fail to appear in Court when I am told or notified of a Court date, and the punishment for such a failure to appear can include a fine, jail, or both.
