As you can tell by all of my documents, letters and photos, I've got a wealth of history and experience. As a young lady, I knew from head that I was called into the ministry, but that was scary and I was enjoying being an K & B singer. I eventually dated John Whitehead Jr of the Epsilons, who later became known as "The Saddest Whitehead with a Smash Hit" "Ain't No Stoppin' Us" now. In March 1971 I met Theodore Pendergrass before he recorded with Herbie Hancock and the Blue Notes. Teddy and I loved each other a lot and on for many years but something was missing

I supernaturally received Prince's hotel phone number. He and I talked for about an hour. We talked of concern. Many personal topics about how Prince knew that God called him to be a preacher, how his dad was an evangelist and how Prince was celebrate

for two years. I shared with Prince that I also was celibate for three years. Prince asked me where I was and I told him I was downstairs in the lobby and his reply was give him ten minutes, he would be down.

When Prince got off the elevator he looked at my friends and me. He ~~he~~ came over to me, he hugged and kissed me and asked me to come back to the hotel after the show. I had never seen Prince on T.V. I didn't realize he had Biking shorts. I myself never own a Biking. After we met I asked Prince could we take pictures together and he said yes. He's holding # my daughter Marissa who had turned three yrs old on Feb-ruary 2, 1980. She is now 39 yrs old when Birth Stone is Purple and she is a Record Producer.

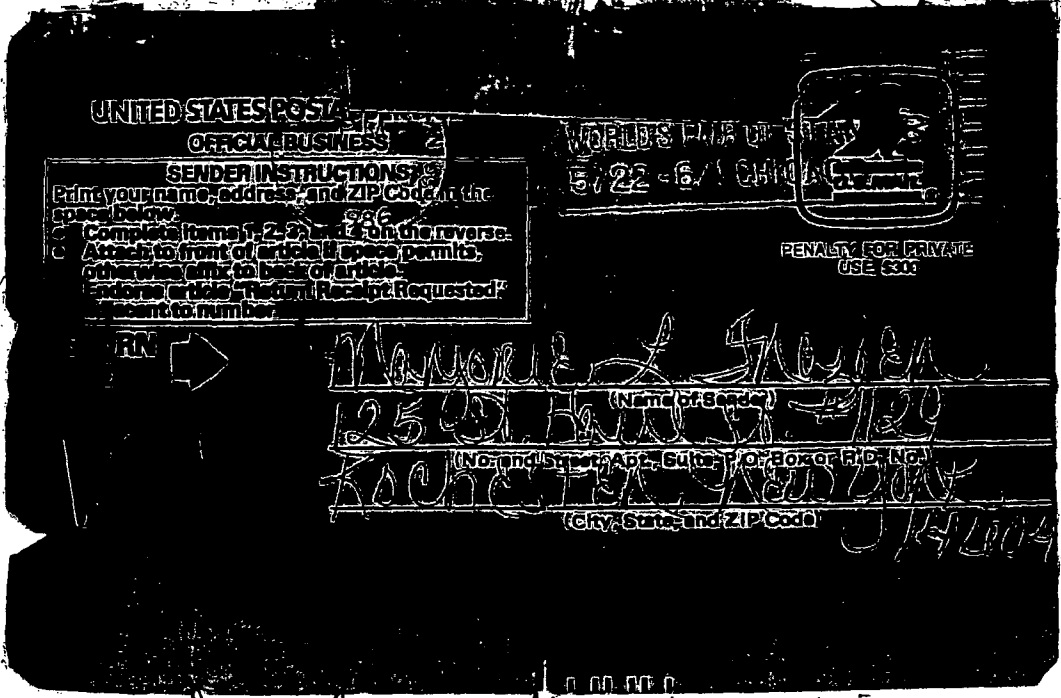

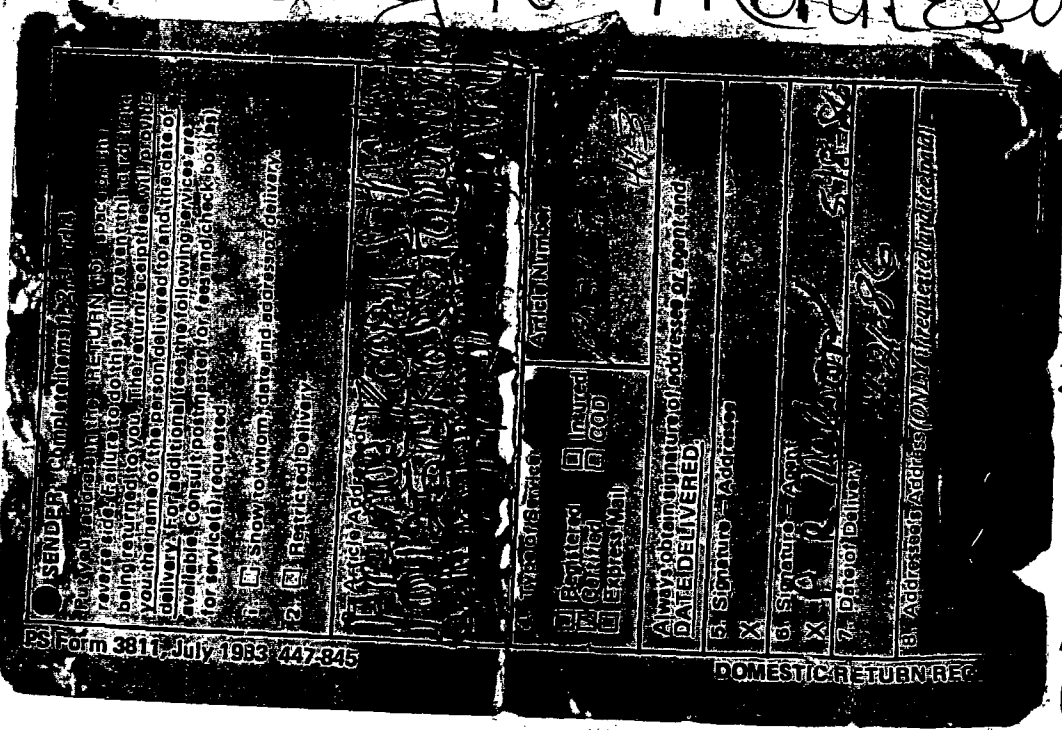
