Stat. § 491A.02, subd. 4(a), a corporation, partnership, limited liability company, sole proprietorship, or association may be represented in Conciliation Court by an officer, manager, or partner (or an agent in the case of a condominium, cooperative, or townhouse association), or may appoint an employee or commercial property manager to appear on its behalf or settle a claim in Conciliation Court.
