Dear Judge Guthmann:

Enclosed with this letter, please find two documents Relators received from Minnesota Pollution Control Agency (“MPCA”) yesterday, December 16, 2019. These documents relate to MPCA’s production of documents retrieved by the Court-ordered forensic search, and are related to Relators’ motions as set forth in their letter of December 12, 2019. Relators request that these documents be considered as exhibits to these informal motions submitted to the Court that will be heard at the December 18, 2019 conference.

Specifically, Relators would call to the Court’s attention: 1) MPCA’s continued withholding of documents due to purported attorney privileges, including documents reflecting communications among staff and documents lacking indicia of privilege; 2) MPCA’s unilateral decision to perform a forensic search using MPCA’s terms and not Relators’ terms, and 3) MPCA’s retention of the jointly-retained forensic search expert to also be its attorney.

Relators will discuss at tomorrow’s conference in connection with the motions previously submitted, enclosed documents, the materials received from MPCA to date pursuant to its unilateral forensic search, and Relators’ continuing concerns that MPCA continues to withhold and fail to produce pertinent documents despite Relators’ best efforts and due diligence.
