1. Does this RFP include any development services?

Possibly, we are open to performing development but would consider a mix of vendor provided development services in conjunction with court provided development.

We're looking to fill any gaps that we have to develop Sharepoint within a new design.

2. What is the mobile approach for this project? Would you prefer a mobile friendly, mobile optimized (m.dot), or adaptive/responsive approach?

3. Please describe what is required to be delivered as a part of the "system overview communication plan".

We have over 3,000 employees who use Sharepoint to varying degrees and we need to consider their communication needs as part of this redesign.

  Search will be a part of the new site, as it is on today's site. We are hoping the taxonomy and information architecture improves search performance as well as reduces the need for search.
