**PETITION BY CERTAIN  
MINNESOTA VOTERS TO HAVE  
THEIR VOTES COUNTED  
PURSUANT TO MINN. STAT. §  
204B.44**

Pursuant to Minn. Stat. § 204B.44, Petitioners petition the Supreme Court of the State of Minnesota to order that their votes cast in the November 4, 2008 general election for United States Senator from Minnesota be counted. Petitioners state and allege as follows:

### **JURISDICTION**

1. This action is necessary to correct errors and omissions made by the Respondents related to the handling of properly cast absentee ballots in the November 4, 2008 election for United States Senator from Minnesota. Respondents are charged with duties concerning the election. This Court's order is necessary to ensure that all properly cast absentee ballots are counted.

2. This Court has jurisdiction over this matter pursuant to Minn. Stat. § 204B.44.

### **PARTIES**

3. Petitioners are Minnesota residents qualified as eligible voters under Minnesota election law who cast absentee ballots in the November 4, 2008 general election for United States Senator from Minnesota. Petitioners' absentee ballots were wrongfully rejected and, therefore, not counted in the final election results.

4. Mark Ritchie is the Minnesota Secretary of State and the chief election official in Minnesota. In his capacity as the Secretary of State, Mr. Ritchie is responsible for the administration of elections in the State of Minnesota, including the November 4, 2008 general election for United States Senator from Minnesota. Mr. Ritchie is included in this action as a necessary party.

5. Carlton County is a political subdivision of the State of Minnesota. The Carlton County canvassing board is responsible for the administration of elections in the County, including the November 4, 2008 general election for United States Senator from Minnesota.

6. Cass County is a political subdivision of the State of Minnesota. The Cass County canvassing board is responsible for the administration of elections in the County, including the November 4, 2008 general election for United States Senator from Minnesota.

7. Clay County is a political subdivision of the State of Minnesota. The Clay County canvassing board is responsible for the administration of elections in the County, including the November 4, 2008 general election for United States Senator from Minnesota.

8. Crow Wing County is a political subdivision of the State of Minnesota. The Crow Wing County canvassing board is responsible for the administration of elections in the County, including the November 4, 2008 general election for United States Senator from Minnesota.

9. Dakota County is a political subdivision of the State of Minnesota. The Dakota County canvassing board is responsible for the administration of elections in the County, including the November 4, 2008 general election for United States Senator from Minnesota.

10. Hennepin County is a political subdivision of the State of Minnesota. The Hennepin County canvassing board is responsible for the administration of elections in the County, including the November 4, 2008 general election for United States Senator from Minnesota.

11. Kittson County is a political subdivision of the State of Minnesota. The Kittson County canvassing board is responsible for the administration of elections in the County, including the November 4, 2008 general election for United States Senator from Minnesota.

12. Lac Qui Parle County is a political subdivision of the State of Minnesota. The Lac Qui Parle County canvassing board is responsible for the administration of elections in the

County, including the November 4, 2008 general election for United States Senator from Minnesota.

13. Lake County is a political subdivision of the State of Minnesota. The Lake County canvassing board is responsible for the administration of elections in the County, including the November 4, 2008 general election for United States Senator from Minnesota.

14. Morrison County is a political subdivision of the State of Minnesota. The Morrison County canvassing board is responsible for the administration of elections in the County, including the November 4, 2008 general election for United States Senator from Minnesota.

15. Olmsted County is a political subdivision of the State of Minnesota. The Olmsted County canvassing board is responsible for the administration of elections in the County, including the November 4, 2008 general election for United States Senator from Minnesota.

16. Pine County is a political subdivision of the State of Minnesota. The Pine County canvassing board is responsible for the administration of elections in the County, including the November 4, 2008 general election for United States Senator from Minnesota.

17. Pope County is a political subdivision of the State of Minnesota. The Pope County canvassing board is responsible for the administration of elections in the County, including the November 4, 2008 general election for United States Senator from Minnesota.

18. Ramsey County is a political subdivision of the State of Minnesota. The Ramsey County canvassing board is responsible for the administration of elections in the County, including the November 4, 2008 general election for United States Senator from Minnesota.

19. Saint Louis County is a political subdivision of the State of Minnesota. The Saint Louis County canvassing board is responsible for the administration of elections in the County, including the November 4, 2008 general election for United States Senator from Minnesota.

20. Stearns County is a political subdivision of the State of Minnesota. The Stearns County canvassing board is responsible for the administration of elections in the County, including the November 4, 2008 general election for United States Senator from Minnesota.

21. Washington County is a political subdivision of the State of Minnesota. The Washington County canvassing board is responsible for the administration of elections in the County, including the November 4, 2008 general election for United States Senator from Minnesota.

22. Winona County is a political subdivision of the State of Minnesota. The Winona County canvassing board is responsible for the administration of elections in the County, including the November 4, 2008 general election for United States Senator from Minnesota.

### **BACKGROUND**

23. Petitioners cast absentee ballots in the November 4, 2008 general election for United States Senator from Minnesota which were not counted in the final election results certified by the State Canvassing Board on January 5, 2009.

24. Under Minn. Stat. § 204B.44, an individual may file a petition with any judge of the Minnesota Supreme Court for the correction of “any wrongful act, omission, or error of any election judge, municipal clerk, county auditor, canvassing board or any of its members, the secretary of state, or any other individual charged with any duty concerning an election.”

25. Associate Justice Alan C. Page previously noted that an individual voter may use the process established in Minn. Stat. § 204B.44 to petition the Supreme Court to have the

voter's ballot counted. Coleman v. Ritchie, No. A08-2169, at D-4 (Minn. Dec. 18, 2008) (Dissent).

### **RESPONDENTS' ERRORS AND OMISSIONS**

26. Respondents did not count Petitioners' properly cast absentee ballots in the November 4, 2008 general election for United States Senator from Minnesota.

27. The ballots for Petitioners 1 through 51, as listed in Exhibit A attached hereto, (hereinafter the "County-Rejected Petitioners") were rejected by county election officials and not counted in the November 4, 2008 general election for United States Senator from Minnesota.

28. For Petitioners 1 through 30, affidavits or declarations under oath were submitted to their counties of residence demonstrating that their absentee ballots were properly cast and, therefore, should have been counted. Affidavit of Charles N. Nauen ("Nauen Aff.") at ¶ 2. However, none of these votes were counted in the November 4, 2008 general election for United States Senator from Minnesota. The affidavits or declarations under oath for Petitioners 1 through 30 are attached to the Nauen Affidavit as Exhibit 1.

29. For Petitioners 31 through 51, verified copies of Minnesota Secretary of State Voter Lookup forms obtained from the official Minnesota Secretary of State Voter File FTP Server were submitted to their counties of residence demonstrating that their absentee ballots were properly cast and, therefore, should have been counted. Nauen Aff. at ¶ 4. However, none of these votes were counted in the November 4, 2008 general election for United States Senator from Minnesota. The verified copies of the Minnesota Secretary of State Voter Lookup forms for Petitioners 31 through 51 are attached to the Nauen Affidavit as Exhibit 2.

30. In Ramsey County, for example, a list of 15 improperly rejected absentee ballots with information demonstrating that the ballots were properly cast was submitted to the County on or about December 12, 2008. Nauen Aff. Ex. 3. On December 29, 2008, Ramsey County

Elections Manager Joe Mansky agreed that two of the absentee ballots included on such list were improperly rejected. Nauen Aff. Ex. 4. Yet, neither these two absentee ballots, nor any of the other improperly rejected absentee ballots, were included in the administrative recount for the November 4, 2008 general election for United States Senator from Minnesota. Nauen Aff. at ¶ 8.

31. For Petitioners 52 through 64, (hereinafter the “County-Identified Petitioners”) their properly cast absentee ballots were identified by the Counties as having been improperly rejected. Yet ballots cast by these County-Identified Petitioners were not included in the administrative recount because they were objected to in the process established by the Minnesota Supreme Court’s December 18, 2008 Order and implemented by the Secretary of State. As a result, these County-Identified Petitioners’ votes were not included in the election results certified by the State Canvassing Board on January 5, 2009. The absentee ballot envelopes and, in some cases, absentee ballot applications for Petitioners 52 through 64 are attached to the Nauen Affidavit as Exhibit 5.

32. For example, in Saint Louis County, 51 ballots were objected to by the Coleman campaign because of “mismatched dates” (i.e. different dates next to the signatures of the voter and the witness on the outer absentee ballot envelopes) even though no dates are required on such envelopes by Minnesota law. Nauen Aff. at ¶ 10.

33. Upon information and belief, County-Identified Petitioners received a letter from Minnesota Secretary of State Mark Ritchie stating that their ballots were not included in the final election results. *See* Nauen Aff. Ex. 5 (Example Letter).

**CLAIM FOR RELIEF**


WHEREFORE, Petitioners respectfully pray for an Order of the Court as follows:

1. Directing that Petitioners' absentee ballots shall be opened and counted, and the total be declared and certified, for such use as might be deemed appropriate by the United States Senate or the judges responsible for the election contest pending in the District Court for the County of Ramsey, No. 62- CV -09-56 or any other proper use under law, pursuant to procedures established by this Court.
2. Granting Petitioner's such other relief as the Court deems just and appropriate.

## AFFIDAVIT/DECLARATION OF JENNIFER BARTHOLOMAY

1. My name is Jennifer Bartholomay. On November 4, 2008, I was eighteen years of age or older, a citizen of the United States, and had maintained residence in Minnesota for at least thirty days immediately preceding the general election held November 4, 2008. I am providing this affidavit because I believe that my November 2008 absentee ballot for that election was improperly rejected because someone determined that my signature on my absentee ballot did not match the signature on my voter registration card or absentee ballot application, and I am hopeful that, by providing this affidavit, my ballot can be verified and counted.

2. As of November 4, 2008, I was fully entitled to vote. I was not under court-ordered guardianship in which the court order revoked my right to vote; had not been found by a court to be legally incompetent to vote; and had not been convicted of treason or any other felony that might disqualify me from voting.

3. I was registered to vote for the November 2008 general election. At the time I registered to vote for that election, my permanent residence was 19630 Estes Path, Farmington, MN 55024 in Dakota County. I was a resident at that address when I requested, received and voted an absentee ballot in the November 2008 general election.

4. Prior to the November 2008 general election, I signed and submitted an application for an absentee ballot. I applied under my correct name and address and used by genuine signature.

~~5. I received an absentee ballot and marked the ballot in the manner prescribed by~~  
the directions sent to me with the ballot. In the U.S. Senate race, I voted for Al Franken. In addition to marking the ballot, I completed the eligibility certificate printed on the back of the envelope and had it witnessed, all as explained in directions I received with the absentee ballot. The eligibility certificate reflected my correct name and address, and it contained my genuine signature.

6. This ballot is the only ballot I submitted in the November 2008 general election. I did not vote in person on November 4, 2008 or submit any other absentee ballot.

7. If notarized below, this is my Affidavit. If not notarized, it is my declaration under 28 U.S.C. § 1746. I declare under penalty of perjury that the foregoing is true and correct.

1. My name is Judith Conlow. On November 4, 2008, I was eighteen years of age or older, a citizen of the United States, and had maintained residence in Minnesota for at least thirty days immediately preceding the general election held November 4, 2008. I am providing this affidavit because I believe that my November 2008 general election ballot was improperly rejected because an election official determined that my absentee ballot was delivered to the wrong precinct, and I am hopeful that, by providing this affidavit, my ballot can be verified and counted.

2. As of November 4, 2008, I was fully entitled to vote. I was not under court-ordered guardianship in which a court order revoked my right to vote; had not been found by a court to be legally incompetent to vote; and had not been convicted of treason or any other felony.

3. I was registered to vote in the State of Minnesota for the November 4, 2008 general election. Prior to November 4, I submitted a request to vote by absentee ballot for the November general election. My address at the time I submitted my application for an absentee ballot and when I voted was 3175 Lakedown Road, Sturgeon Lake, MN 55783 in Pine County.

4. I received the absentee ballot and marked this ballot as prescribed in the instructions included with the absentee ballot form. In the U.S. Senate race, I voted for Al Franken. In addition to marking the ballot, I completed the eligibility certificate printed on the back of the envelope and then returned it by mail, using the return envelope that the county provided with the absentee ballot. I signed the ballot with my genuine signatures. I did not submit any other ballots in the November 4, 2008 election.

5. I have not been informed by any election official that there was a problem with my ballot. I am not aware of any reason for election officials to reject my absentee ballot and refuse to count my vote.

## AFFIDAVIT/DECLARATION OF URSELA COWAN

1. My name is Ursela Cowan. On November 4, 2008, I was eighteen years of age or older, a citizen of the United States, and had maintained residence in Minnesota for at least thirty days immediately preceding the general election held November 4, 2008. I am providing this affidavit because I believe that my November 2008 absentee ballot for that election was improperly rejected, and I am hopeful that, by providing this affidavit, my ballot can be verified and counted.

2. As of November 4, 2008, I was fully entitled to vote. I was not under court-ordered guardianship in which the court order revoked my right to vote; had not been found by a court to be legally incompetent to vote; and had not been convicted of treason or any other felony that might disqualify me from voting.

3. I was registered to vote for the November 2008 general election. At the time I registered to vote for that election, my permanent residence was 1275 Belmont Lane West, Roseville, MN 55113, in Ramsey County. I was a resident at that address when I requested, received and voted an absentee ballot in the November 2008 general election.

4. Prior to the November 2008 general election, I signed and submitted an application for an absentee ballot. I applied under my correct name and address and used by genuine signature.

5. I received an absentee ballot and marked the ballot in the manner prescribed by the directions sent to me with the ballot. In the U.S. Senate race, I voted for Al Franken. On the outside of the absentee ballot envelope, there was a sticker containing a bar code, my name and address and other numbers and information. Because this sticker was placed on top of the section entitled "To Be Completed By Voter" and covered up almost all of that section, I did not fill in any additional information and did not sign the ballot envelope. My vote was duly witnessed and the section entitled "To Be Completed By Witness" was completed. I now understand that I was required to sign the envelope to certify that I was in fact eligible to vote by absentee ballot. However, the certification was almost completely covered by the sticker. Had I been able to read the certification, I would have signed.

6. This ballot is the only ballot I submitted in the November 2008 general election. I did not vote in person on November 4, 2008 or submit any other absentee ballot.

7. If notarized below, this is my Affidavit. If not notarized, it is my declaration under 28 U.S.C. § 1746. I declare under penalty of perjury that the foregoing is true and correct.

## AFFIDAVIT/DECLARATION OF JEFFREY DUSTIN

On November 4, 2008, I was eighteen years of age or older, a citizen of the United States, and had maintained residence in Minnesota for at least thirty days immediately preceding the general election held November 4, 2008. I am providing this affidavit because I believe that my November 2008 general election ballot was improperly rejected, and I am hopeful that, by providing this affidavit, my ballot can be verified and counted.

2. As of November 4, 2008, I was fully entitled to vote. I was not under court-ordered guardianship in which a court order revoked my right to vote; had not been found by a court to be legally incompetent to vote; and had not been convicted of treason or any other felony.

3. I was registered to vote in the State of Minnesota for the November 4, 2008 general election. Prior to November 4, I submitted a request to vote by absentee ballot for the November general election. My address at the time I submitted my application for an absentee ballot and when I voted was 529 Maple Lane, Moorhead, MN in Clay County.

Dear Messrs. Mansky and Lookingbill:

Thank you for the lists you furnished on December 22 recommending that certain absentee ballots rejected due to election judge or office staff error be opened and counted.

However, we request that Ramsey County add the following voters (in alphabetical order) to those lists:

1. Muriel Anderson. Ramsey County Elections states that she was properly rejected because she did not sign her voter registration card. However, the Secretary of State database shows that she was already registered in the same precinct and thus was eligible to vote.
2. Catherine Brigham. Ramsey County Elections states that she was properly rejected because she registered after her absentee ballot had been processed. However, the Secretary of State database shows that she was registered as of October 8, 2008, which is the day she dated her absentee ballot. Logically, her ballot was processed after October 8.
3. Emma Bruggeman. Ramsey County Elections states that she was properly rejected because she registered after her absentee ballot had been processed. However, Ms. Bruggeman was already registered at the address from which she applied. She was issued the wrong envelope in response to her application.
4. Ursula Cowan. We do not yet have a response from Ramsey County Elections as to why her ballot is not recommended for opening and counting. The sticker with the voter address and name at least partially covered up the voter eligibility certificate.

5. Josephine Garcia. Ramsey County Elections states that she was properly rejected because the signature on the ballot envelope does not match the signature on the application. However, she has submitted a declaration stating that she had her son sign the application because she has glaucoma and rheumatoid arthritis, and that she considers both that signature and her signature on the ballot to be genuine signatures.
6. Gerald Gauster. We do not yet have a response from Ramsey County Elections as to why his ballot is not recommended for opening and counting. He has submitted an affidavit confirming that he was registered and he submitted the ballot.
7. Lorraine Gauster. We do not yet have a response from Ramsey County Elections as to why her ballot is not recommended for opening and counting. She has submitted an affidavit conforming that she was registered and she submitted the ballot.
8. Sophie Hall. Ramsey County Elections states that she was properly rejected because she was issued the wrong materials. That is not a proper reason for rejection.
9. Alexis Horan. We do not yet have a response from Ramsey County Elections as to why her ballot is not recommended for opening and counting. She was rejected for lack of registration, but a review of the Secretary of State database confirms her registration.
10. Michael Liebig. Ramsey County Elections states that he was properly rejected because there was no voter registration card. However, a review of the Secretary of State database shows that Mr. Liebig is registered.
11. Tempest Moore. We do not yet have a response from Ramsey County Elections as to why her ballot is not recommended for counting. She was rejected for "proof of residency." A review of the Secretary of State database confirms her registration.
12. Lewanne Morphew. Ramsey County Elections office states that she was properly rejected because there was no voter registration card completed. A review of the Secretary of State database indicates that she was already registered and had a history of voting.
13. John Redmond. Ramsey County Elections states that he was properly rejected because his signature on his ballot envelope did not match his signature on his application. The declaration of the voter states he used his genuine signature on both, and he signed both himself.
14. John Robertus. Ramsey County Elections states that he was rejected because the witness/proof of residence was not completed properly. Mr. Robertus provided evidence of his

new residence, an assisted living facility, to the clerk at New Brighton City Hall, where he voted. Although there is no driver's license number on the outside of the envelope, Mr. Robertus no longer drives. The mistake was that of his witness, the city official.

15. Walter Thompson. Although we have not received a response from Ramsey County Elections, we have submitted a declaration from the voter stating that he is blind and was ill when he submitted the application. His wife, who has a power of attorney, signed his application at his direction with his genuine signature and then he signed the ballot envelope with his genuine signature with his wife guiding his hand. The voter states that both are his genuine signatures.

The two campaigns are to review the county error lists this weekend. Accordingly, we request that you respond as soon as possible to this letter.





Your absentee ballot was not counted in the November election.

In a recent meeting to discuss the inclusion of your vote in the United States Senate recount, your ballot was rejected. Attached is a copy of a form that a representative or one of the candidates completed explaining the denial. The form states the name of the denying individual, which campaign they represented, and the reason.

Minnesota law provides at least two possible options for voters who believe that their right to vote has been wrongly denied. One is referred to as "Errors and Omissions" and is described in *Minnesota Statutes*, section 204B.44. The other is the election contest process found in *Minnesota Statutes*, section 209.02. The election contest must be filed by Monday, January 12, 2009 (seven calendar days after the Canvassing Board certified the vote). Only the results in the United States Senate race are still open to contest.

Our office cannot provide legal advice on this matter. You may want to consult with an attorney to determine what course of action, if any, to take.
