**RELEASE WITH CONDITIONS**

Defendant shall be released upon:

- Personally promising to obey all of the RELEASE CONDITIONS
- Posting a secured bond or cash bail in the amount of 200,000

or  
Posting a cash deposit as bail in the amount of \_\_\_\_\_ accompanied by a written surety and undertaking of a surety on behalf of the defendant acceptable to the Judge assuring the defendant's appearance.

In all of the above cases, the defendant shall obey the following RELEASE CONDITIONS:

- Appear at all future court hearings
- Be of good behavior and obey all laws of the United States and the State of Minnesota
- Not leave the State of Minnesota without Court permission
- Report any address changes to the Court Administrator and defendant's attorney, if any
- Complete all required booking procedures prior to the next court appearance in the case of a felony, gross misdemeanor or DWI case.
- Contact and stay in contact with your attorney
- No unnecessary contact with witnesses
- \_\_\_\_\_ Totally abstain from the use of alcohol and drugs unless prescribed for you by your physician. You shall not enter bars or liquor stores. The defendant shall submit to random drug or alcohol testing by probation or law enforcement authority.
- No direct or indirect contact with Families who are victims and stay 100 yards from their residence.
- Other weekly contact with probation

**IN DOMESTIC ASSAULT, VIOLATION OF ORDERS FOR PROTECTION OR VIOLATION OF HARASSMENT ORDER CASES, THE FOLLOWING SHALL ALSO APPLY:**
