
WHEREAS the term of William J. Ridley as a member of the State Board of Law Examiners expired July 1, 1983, and

The Court having accepted the resignation of William J. Ridley, whose term expires January 1, 1987, and


WHEREAS John B. Davis is willing to accept appointment to that seat on the Board, and






