ORDER APPOINTING
TEMPORARY APPEAL
PANEL MEMBER

WHEREAS, by order dated May 24, 1982, this court appointed an appeals panel pursuant to Minn. IT IS FURTHER ORDERED that the compensation of said temporary panel member shall be fifty dollars (\$50.00) for each half day of his service.



IT IS FURTHER ORDERED that the Honorable Gerald W. Kalina is hereby appointed Chief Judge of said appeal panel.


