**ORDER ESTABLISHING JUVENILE  
PROTECTION RULES COMMITTEE**

On December 29, 1999, the Court issued an Order promulgating Rules 37-82 of the Rules of Juvenile Procedure (Juvenile Protection Rules) to be effective March 1, 2000.

It is anticipated that amendments to the Juvenile Protection Rules will be necessary due to changes in case law and federal and state statutes.

**NOW, THEREFORE, IT IS HEREBY ORDERED THAT:**

1. The Minnesota Supreme Court Juvenile Protection Rules Committee is hereby established to:

- a. Review case law relating to the Juvenile Protection Rules;
- b. Review federal and state statutes relating to the Juvenile Protection Rules;
- c. Monitor implementation of, and consider requests for revisions to, the Juvenile Protection Rules; and
- d. Submit to the Court recommendations for necessary revision of the Juvenile Protection Rules.

2. At least annually the Committee shall report to the Court any recommendations for revision of the Juvenile Protection Rules. Annual reports shall be submitted by December 15, with the initial report due December 15, 2002.

3. Honorable Timothy Bloomquist, Kanabec County District Court Judge, is appointed as Committee Chair for a three-year term commencing June 1, 2001, and ending June 30, 2004.


