**THIRD AMENDED ORDER ESTABLISHING ADVISORY COMMITTEE
ON THE AMENDMENT OF THE JUVENILE PROTECTION RULES**

WHEREAS, legislation enacted over the past five to ten years has impacted the Juvenile Protection Rules; and

WHEREAS, the Minnesota Supreme Court Advisory Task Force on Foster Care and Adoption recommended review and revision of the Juvenile Protection Rules; and

WHEREAS, the Supreme Court requests the appointment of an advisory committee to make recommendations regarding revision of the Juvenile Protection Rules;

NOW, THEREFORE, IT IS HEREBY ORDERED THAT the Advisory Committee on the Amendment of the Juvenile Protection Rules be, and hereby is, established.

IT IS FURTHER ORDERED THAT the Committee shall:

1. Review the existing Juvenile Protection Rules, relevant federal and state statutes, the Final Report of the Foster Care and Adoption Task Force, relevant case law, and other relevant materials; and
2. Make recommendations regarding revision of the Juvenile Protection Rules.


IT IS FURTHER ORDERED THAT Ann Ahlstrom and Gail Baker be, and hereby are, designated as Committee Co-Chairs.
