


ORDER

ON PROFESSIONAL CONDUCT


Your Petitioner, R. Paul Sharood, respectfully states and shows to the Court:

That Sheldon S. Larson, an Attorney practicing at Winthrop, Minnesota, was duly appointed by the Court to the State Board of Professional Responsibility for a term of three years which will terminate on January 31, 1975. That the Court has appointed his successor whose term is effective as of February 1, 1975.

That Mr. Larson is presently a member of a Panel of the Board presently convened to consider charges of professional misconduct against an attorney; that hearing on said charges will not be completed nor decision made thereon until after January 31, 1975; and that it is necessary and expedient that Mr. Larson continue as a member of the Board for the limited purpose of participating as a member of the mentioned Panel until final action is taken on the charges presently being considered by it.
