WHEREAS, under said Rules, the office of State Administrative Director on Professional Conduct is established, and

WHEREAS, under said Rules, the Administrative Director, when authorized and empowered by this Court, may employ such persons as he may from time to time deem necessary, at such compensation as this Court may approve, and

WHEREAS, the Administrative Director has employed DANIEL G. HELLY as Assistant Administrative Director on Professional Conduct at a salary of Twenty-four Thousand (\$24,000.00) Dollars per year, effective November 1, 1976, subject to the approval of the Court,

NOW, THEREFORE, IT IS ORDERED that the appointment of DANIEL G. HEELY as above set forth be, and hereby is, approved, and the salary of DANIEL G. HEELY is fixed at the sum of Twenty-four Thousand (\$24,000.00) Dollars per year, to be paid One Thousand Dollars (\$1,000.00) on November 15, 1976, and semi-monthly thereafter.





WHEREAS, under said Rules, the office of State Administrative Director on Professional Conduct is established, and


