

O R D E R

Pursuant to 1978 Minn. Laws, ch. 723, § 9, subd. 2(1), the undersigned as Chief Justice of the Supreme Court of the State of Minnesota hereby appoints the Honorable Douglas K. Amdahl, Justice of the Minnesota Supreme Court, to serve on the Minnesota Sentencing Guidelines Commission for the unexpired term of the Honorable George M. Scott who was appointed pursuant to 1978 Minn. Laws, ch. 723, § 9, subd. 2(1) by order dated April 11, 1978, for a four-year term expiring April 5, 1982 (four years from the effective date of the Act).

Pursuant to 1978 Minn. Laws, ch. 723, § 9, subd. 2(2), the undersigned as Chief Justice of the Supreme Court of the State of Minnesota hereby appoints the Honorable David E. Each member shall continue in office until his successor is duly appointed. \* \* \* appointment may be made to fill an unexpired term."
