<ul style="list-style-type: none"> <li>Pick up Jury Trial files from criminal division 35 days prior to Settlement Conference (date noted on calendar)</li> <li>Review files for 1 week and determine which cases will be scheduled for Settlement Conference.</li> <li>Issue Scheduling Order(s) setting designated cases for Settlement Conference. (Note: Please use Settlement Conference date designated on calendar).</li> <li>Return files and Settlement Conference Orders to Criminal Division (date noted on calendar). FYI - The reason this step is so important is because it will allow the criminal staff to file all incoming documents into the file. As such, when the settlement conference date arrives your files will be properly updated.</li> <li>Please note that on your SC date you will have half of the COH calendar in addition to your SC's.</li> </ul>
