On November 4, 2008, I was eighteen years of age or older, a citizen of the United States, and had maintained a residence in Minnesota for at least thirty days immediately preceding the general election held November 4, 2008. I am providing this declaration because I believe that my November 2008 absentee ballot for that election was improperly rejected.

2. As of November 4, 2008, I was fully entitled to vote. I was not under court-ordered guardianship in which the court order revoked my right to vote; had not been found by a court to be legally incompetent to vote; and had not been convicted of treason or any other felony that might disqualify me from voting.

3. I was registered and eligible to vote in the precinct where I cast my vote for the November 2008 general election. At the time, my permanent residence was 191 Wildwood Drive, Esko, MN in Carlton County. I was a resident at this address when I requested, received and voted an absentee ballot in the November 2008 general election.

4. Prior to the November 2008 general election, I completed, signed, dated and submitted an application for an absentee ballot. I applied for an absentee ballot under my correct name and my permanent residence and used my genuine signature.
