The judgment creditor, or the creditor's agent or attorney must complete this form.

- 1. Enter the full title of the case.
- 2. Enter the case number.
- 3. Enter the judgment creditor's complete name, occupation, place of residence and post office address.

Note: If creditor lives in an incorporated place of more than 5,000, the street and number of both residence and business must be given.

- 4. The judgment creditor, creditor's agent or attorney must list their name, address, telephone number and attorney ID number if appropriate.
- 5. Sign the form before a Notary Public or before a Hennepin County District Court Clerk in the Civil Division.
- 6. If you are a creditor's attorney, you must e-file the documents to the Hennepin County District Court through the E-File and Serve System.
- 7. Pro Se individual, mail the Affidavit of Identification of Judgment Creditor along with other foreign judgment filing documents and fee to:
