NOW, THEREFORE, IT IS HEREBY ORDERED that a hearing be had before this Court in the courtroom of the Minnesota Supreme Court, State Capitol, on Friday, March 8, 1985, at 9:30 a.m., for the purpose of hearing proponents or opponents of the proposed amendments.

IT IS FURTHER ORDERED that advance notice of the hearing be given by the publication of this Order once in the Supreme Court editions of FINANCE AND COMMERCE, ST. PAUL LEGAL LEDGER, and BENCH AND BAR.

IT IS FURTHER ORDERED that any person wishing to obtain a copy of the proposed amendments write to the Clerk of the Appellate Courts, 230 State Capitol, St. Paul, Minnesota, 55155.

IT IS FURTHER ORDERED that all citizens, including members of the Bench and Bar, desiring to be heard, shall file briefs or petitions setting forth their positions and shall notify the Clerk of the Appellate Courts, in writing, on or before February 15, 1985, of their desire to be heard on the proposed code. Ten copies of each brief, petition, or letter shall be supplied to the clerk.
