SUPREME COURT ADVISORY COMMITTEE SOLICITS COMMENTS AND QUESTIONS ABOUT CODE OF JUDICIAL CONDUCT

ST. PAUL, MN -- The Minnesota Supreme Court has established an Advisory Committee to review the standards governing the ethical conduct of judges in Minnesota. This review will focus on the standards recommended by the American Bar Association in its 1990 Model Code of Judicial Conduct. The advisory committee also will review the procedures for handling ethical complaints made against judges that are filed with the Board on Judicial Standards.

"In its ongoing effort to continually improve itself, the judiciary is inviting comments from the public about the code of conduct that governs the behavior of judges," said Chief Justice A. M. Keith. "The meetings and the soon-to-be-scheduled public hearing provide an opportunity for interested individuals and organizations to give the court system the benefit of their thoughts on the ethical standards to which judges should be held."

The advisory committee is composed of five judges, five lawyers, and five non-lawyer citizens. Members are: Hon. Thomas R. The advisory committee also plans to hold a public hearing to receive testimony from interested parties. Notice of the hearing date and location will be published at a later time. The advisory committee is scheduled to complete its review by Dec. 31, 1993.
