**In re Stenographic Court Reporters Minimum Qualifications and Administrative Procedures**

In furtherance of Supreme Court Order dated April 23, 1993 requiring the Registered Professional Reporter designation from the National Court Reporters Association for official stenographic court reporter service,

The Supreme Court promulgates this order memorializing the names of those individuals specified in paragraph 3 of the April 23, 1993 Order who were appointed and serving on July 1, 1993 as stenographic reporters and/or who have as of January 1, 1994 filed an affidavit as required by paragraph 2cii of the Order that they were a practicing stenographic reporter. All individuals on these two lists are deemed to meet the minimum qualifications for official or per diem stenographic court reporter positions without providing the RPR Certificate as proof of qualification. All other candidates for per diem or official stenographic court reporter positions in the judicial branch shall provide to the judicial district administrator where the reporter is serving a copy of the RPR Certificate prior to receiving compensation. The copy of the RPR Certificate shall remain on file in the district administrator's office.
