ORDER APPOINTING APPEAL PANEL

WHEREAS, the Chief Justice of the Supreme Court is required to appoint an appeal panel under the provisions of Minn. Stat. § 253A.15, subd. 2(b) (1978),

NOW, THEREFORE, IT IS HEREBY ORDERED that the following named probate judges are appointed members of the appeal panel for a period of one year from May 17, 1980:

IT IS FURTHER ORDERED that the following named probate judges are appointed alternate members of said appeal panel for a period of one year from May 17, 1980:

IT IS FURTHER ORDERED that the Honorable Andrew A. Glenn is hereby appointed Chief Judge of said appeal panel.

IT IS FURTHER ORDERED that the order appointing appeal panel pursuant to Minn. Stat. § 253A.15, subd. 2(b) (1971) dated May 17, 1979 is hereby superseded.

IT IS FURTHER ORDERED that the compensation of said panel members shall be Fifty and no/100 Dollars (\$50.00) for each half-day they are required to serve.

The Honorable Paul Kimball, Jr.


IT IS FURTHER ORDERED that the compensation of said panel member shall be Fifty and no/100 Dollars (\$50.00) for each half-day he is required to serve.
