Order Establishing  
Minnesota Jury Standards Committee

WHEREAS National Standards Relating to Juror Use and Management have been developed and have been adopted by the American Bar Association,

WHEREAS efficient court administration will best guarantee the preservation of the jury system and enhance the quality of the decision-making process,

WHEREAS the jury system provides citizens with an opportunity to learn, observe and participate in the judicial process, and

WHEREAS courts must insure that jury resources are utilized to the maximum degree of efficiency, while minimizing inconvenience to individual citizens,

NOW, THEREFORE, IT IS ORDERED that a thirteen person committee designated as the Minnesota Jury Standards Committee be, and hereby is, established to review and make recommendations to the Supreme Court on the implementation of the American Bar Association Standards for Juror Use and Management.


