
ORDER

RULES OF THE SUPREME COURT ON LAWYER REGISTRATION

Rule 2. Registration Fee

D. Allocation of Fees

Fees paid pursuant to this rule are allocated according to the following schedule:

(1) Payments of \$217 are allocated as follows:

- \$23 to the State Board of Law Examiners;
- \$6 to the State Board of Continuing Legal Education;
- \$122 to the Lawyers Professional Responsibility Board;
- \$0 to the Client Security Fund (no fee collected October 1, 2008 through July 1,

2009 registration deadline cycles);

· \$50 to the Legal Services Advisory Committee for civil legal services and grant program purposes; and

· \$16 to the ~~Lawyer Trust Account Board~~ Legal Services Advisory Committee for a lawyers assistance program.

(2) Payments of \$192 are allocated as follows:

- \$23 to the State Board of Law Examiners;
- \$6 to the State Board of Continuing Legal Education;

- \$122 to the Lawyers Professional Responsibility Board;
- \$0 to the Client Security Fund (no fee collected October 1, 2008 through July 1, 2009 registration deadline cycles);

- \$25 to the Legal Services Advisory Committee for civil legal services and grant program purposes; and

- \$16 to the ~~Lawyer Trust Account Board~~ Legal Services Advisory Committee for a lawyers assistance program.

(3) Payments of \$178 are allocated as follows:

RULE 7. ACCESS TO LAWYER REGISTRATION RECORDS

D. Trust Account Information. Trust account information submitted by lawyers and judges as part of the lawyer registration process is not accessible to the public, ~~except as provided in the Rules of Lawyer Trust Account Board.~~
