IT IS ORDERED that effective December 1, 1989, Sentencing Worksheet Form No. SG-0001-04 and Supplement to Sentencing Worksheet Form No. SG-0002-04 in the forms attached hereto be used by all Minnesota District Courts as proper forms for sentencing worksheet purposes under Minnesota Sentencing Guidlines requirements.
