ADDENDUM TO THE CONFIDENTIALITY STIPULATION

Pursuant to this addendum, Comerica Bank & Trust N.A. ("Comerica") hereby agrees to be bound in the same manner as Bremer Trust, N.A., in its role as Special Administrator of the Estate of Prince Rogers Nelson ("Bremer Trust"), to the terms of the Confidentiality Stipulation entered into between Petitioners Roc Nation LLC, WiMP Music AS and Aspiro AB, on the one hand, and Bremer Trust, on the other hand, which stipulation was so-ordered by the Honorable Kevin W. Eide of the Carver County, Minnesota Courthouse, First Judicial District on January 12, 2017 (the "Confidentiality Stipulation") in the matter styled *In re: Estate of Prince Rogers Nelson* (No. 10-PR-16-46). A true and correct copy of the Confidentiality Stipulation is attached hereto. Notwithstanding the foregoing, Petitioners agree that, despite its designation as "highly confidential" under the Confidentiality Stipulation, counsel for Comerica may share the Equity Term Sheet with Comerica. Further, nothing herein shall prevent Comerica from challenging Petitioners' designation of any Discovery Material (including the Equity Term Sheet) as confidential or highly confidential in the manner provided in Section 10 of the Confidentiality Stipulation. Likewise, nothing herein shall prevent Petitioners from challenging the ability of Comerica or Bremer Trust to challenge the designation of the Equity Term Sheet as "highly confidential," whether pursuant to Section 10 of the Confidentiality Stipulation or otherwise.
