Steven H. Silton, after being duly sworn, states:

1. I am an attorney duly licensed to practice and in good standing in the State of Minnesota and, if called as a witness, I could and would competently testify to the facts stated herein based on my own personal knowledge.
2. I am an attorney at Cozen O'Connor ("Cozen"), counsel of record for Omarr Baker. I make this affidavit in support of Omarr Baker's Motion for Approval of Payment of Attorneys' Fees and Costs from Assets of the Estate.
3. Cozen was retained by Omarr Baker ("Baker") in June 2016 to provide legal services and specialized advice regarding the Estate of Prince Rogers Nelson (the "Estate"). Cozen formally appeared in the matter on June 23, 2016. True and accurate copies of the invoice for which Baker seeks payment from the Estate, which related to the services that benefitted the Estate as a whole, is attached as **Exhibit A**. Through his Motion, Baker is not seeking

reimbursement from the Estate for services that arguably benefitted Baker individually— but rather, for services that benefitted the Estate as a whole.

4. On August 30, 2016, the Court issued an “Order Adopting Modified Protocol for Business Agreements” (the “August 30 Order”). The August 30 Order required the Special Administrator to provide a copy of any proposed “Major Deal” counsel for Omarr Baker, Alfred Jackson, John Nelson, Norrine Nelson, Sharon Nelson, and Tyka Nelson (the “Non-Excluded Heirs”). The Non-Excluded Heirs had 72 hours to provide an objection. If any party objects, the parties were to attempt to resolve the issue and, if that is not possible, then to schedule a telephone conference with the Court.
5. On August 30, 2016, the Court conducted a telephone conference with the parties on August 30, 2016 regarding a proposed contract with [REDACTED]. I attended the conference on behalf of Baker. In requesting approval of the [REDACTED] agreement, the Special Administrator Bremer Trust, National Association (“Bremer” or “Special Administrator”) argued that [REDACTED]

7. In anticipation of the August 30 Hearing, Cozen conducted extensive research and preparation for argument. Cozen attorney Thomas P. Kane also worked extensively with

12. During much of the time period covered by this Application, I corresponded extensively with the Representatives, counsel for Bremer, and counsel for the other Non-Excluded Heirs regarding the [REDACTED] agreements.
13. No prior drafts of the [REDACTED] agreements were provided to the Non-Excluded Heirs, and comments were to be provided on an expedited basis. Thus, I relied on other Cozen attorneys to assist in our analysis of proposed agreements, particularly to assess [REDACTED]

14. I, along with other attorneys at Cozen, engaged in frequent communications with counsel for the other Non-Excluded Heirs, the Representatives, the Special Administrator, and the Special Administrator's Entertainment Advisors (the "Advisors") to offer input and assist in negotiating amendments to the deals in order to provide status updates and prepare strategy.
15. On November 9, 2016, Mr. Abdo and his firm withdrew from the underlying litigation, and Frank K. Wheaton, counsel to Alfred Jackson, replaced him as the other Representative for the Non-Excluded Heirs.
16. I am well-qualified to provide counsel in the realm of entertainment law, based on my more than 20 years' experience in entertainment law, including serving as an Advisory Board member of the University of Miami School Sports and Entertainment Law LLM.
17. My colleague Jeffrey Kolodny is also well-qualified to serve as counsel in these proceedings. Mr. Kolodny practices on complex international and domestic estate planning

and administration, with a focus on wealth preservation through effective tax planning, structuring and personal planning for high net worth individuals and multinational families.

18. To assist in the briefing for matters that required the Court's attention, Cozen professional Thomas Kane was primarily involved, although other timekeepers were utilized as reasonable and appropriate. Mr. Kane has extensive experience litigating high profile, complex litigation, and his knowledge and experience provided immense benefit to the Estate.
19. From June 2016 through November 30, 2016, I, with the assistance of other Cozen attorneys, provided a variety of services to the Estate which significantly improved the long-form agreements and which provided greater involvement by the Non-Excluded Heirs in the negotiating process. This work included:

- Briefing the issue for the Court, resulting in the Order allowing [REDACTED]

 - Participating in telephonic conferences and preparing emails regarding [REDACTED]

20. In providing legal services sought by this Motion, Cozen attorneys and paralegals have expended 1,122 hours from June 22, 2016 through November 30, 2016. Due to attorney-client privilege and attorney work product protection, redacted billing statements are filed publicly with this Motion. Cozen's unredacted time records have been provided for the Court's review.
21. From June 23, 2016 through November 30, 2016, attorneys at Cozen performed services that were reasonably and necessarily incurred to secure the right of the Representatives to participate in the negotiation and finalizing of six proposed entertainment deals advanced by the Special Administrator. Such services performed by Cozen for the benefit of the Estate have included but have not been limited to the following tasks performed by various attorneys:

Briefing, Hearings, and Issues regarding Entertainment Deals

22. Cozen conducted research, prepared arguments, and presented arguments to the Court on August 30 and September 29, 2016.

23. In my opinion, the Cozen time is sought for reimbursement for efforts related to these hearings, briefings, and issues regarding the entertainment deals is just and reasonable and commensurate with the benefit to the Estate.

Preparing Comments and Developing Consensus for [REDACTED] Deals

24. Cozen attorneys conferred with the Representatives to reach a consensus among counsel for all Non-Excluded Heirs. Upon developing a consensus, the Representatives provided detailed redlines and comments to the Advisors for the [REDACTED] and extensive comments for the [REDACTED]

25. The Representatives travelled to New York to meet with Advisors to discuss the two proposed deals. Following that meeting, I—along with counsel for the other Non-Excluded Heirs—engaged in many telephone calls, emails, exchanges of information and re-drafts of the [REDACTED] agreement over several weeks.

[REDACTED] As discussed below, this lapse led Tyka Nelson and Omarr Baker to request the adoption of formal protocols so that it was not repeated.

30. In addition to the review of the [REDACTED] deals, the Representatives recently prepared and submitted comments, on behalf of the Non-Excluded Heirs, to the current version of the [REDACTED] agreement.

31. During this process, I and other Cozen attorneys engaged in frequent conversations and email exchanges with other counsel for the other Non-Excluded Heirs, with counsel for the Special Administrator, and with the Advisors to offer comments, to assist in negotiating amendments to the deals, and to obtain agreement on a joint strategy.

32. Cozen's efforts resulted in [REDACTED] and provided material benefits to the Estate.

33. In my opinion, the Cozen time sought for reimbursement for efforts related to the negotiation of the proposed Entertainment deals is just and reasonable and commensurate with the benefit to the Estate.

Protocol Order

35. Several conferences between the Non-Excluded Heirs and the Special Administrator regarding a formal protocol for the remaining negotiations took place but an acceptable resolution was not reached. As a result, [REDACTED]

37. Subsequently, the parties continued their meet and confer process. While the meet and confer effort brought the parties closer together, a resolution was not reached and each side submitted their proposed protocol orders to the Court. The Representatives submitted a proposed protocol order to the Court.

39. As a result of the Motion and subsequent order, the Parties now have further clarity and definition regarding the negotiating process for the remaining four deals which will allow the maximum benefit for the Estate to be reached [REDACTED]
40. These efforts benefitted the Estate, by again confirming the role of the Representatives in the negotiation process, and providing a level of certainty to the Non-Excluded Heirs and the Estate's partners that the best interests of the Estate were being served by the proposed deals. Petitioners now seek reimbursement from the Estate for its efforts.
41. In my opinion, the Cozen time is sought for reimbursement for efforts related to the Protocol issue is just and reasonable and commensurate with the benefit to the Estate.
42. Cozen's legal fees are in the total amount of \$491,799.00 for services sought by this Motion. I and other attorneys at Cozen have reviewed the original time entries for the legal fees submitted by Cozen and affirm that the work was actually performed for the benefit of the Estate, was necessary for the proper administration of the Estate, and that the fees are reasonable given (1) the time and labor required; (2) the complexity and novelty of the transactions involved; and (3) the extent of the responsibilities assumed and the results obtained. The coordination of work required over several sophisticated and complex disciplines, and the time demands required finds the pending fee request reasonable under these unique circumstances. Furthermore, our firm's hourly rates and overall charges are fair when compared against the fees charged for comparable work for similar firms in other major metropolitan areas.
43. Given the complexity of the litigation, the Entertainment deals the Estate is negotiating and the results achieved, \$491,799.00 is a just and reasonable amount to be requested.
44. Costs advanced to be reimbursed total \$5,857.24.
