

STATE OF MINNESOTA IN SUPREME COURT ADM10-8049

ORDER ESTABLISHING PUBLIC COMMENT PERIOD AND PUBLIC HEARING ON PROPOSED AMENDMENTS TO THE MINNESOTA RULES OF CRIMINAL PROCEDURE

On December 20, 2022, we directed the Minnesota Supreme Court Advisory Committee on the Rules of Criminal Procedure to review Rule 20 of the Minnesota Rules of Criminal Procedure and consider whether any amendments to the Rule are required or appropriate in light of a new law regarding mental health policy, which includes new requirements regarding competency-related procedures. *See* In re the Minnesota Supreme Court Advisory Committee on the Rules of Criminal Procedure, No. ADM10-8049 (Minn. filed Dec. 20, 2022) (citing Act of June 2, 2022, ch. 99, art. 1, §§ 26–37, 2022 Minn. Laws 992, 1020–1037). The committee filed its report and recommendations on December 15, 2023. The committee's report with proposed amendments is available on the public access site for the Minnesota Appellate Courts, under case number ADM10-8049—*Report and Proposed Amendments to the Minnesota Rules of Criminal Procedure* (filed Dec. 15, 2023).

We will consider the proposed amendments to Rule 20 of the Minnesota Rules of Criminal Procedure after providing a period for public comment and a public hearing, and reviewing any comments received and considering any presentation made.¹

of or in opposition to the amendments proposed to Rule 20 of the Minnesota Rules of

Criminal Procedure shall file those comments with the Clerk of the Appellate Courts, using

the appellate courts' e-filing application, E-MACS, if required to do so. See Minn. R. Civ.

App. P. 125.01(a). All comments shall be filed so as to be received by the Clerk's office

no later than Monday, April 29, 2024.

2. A hearing will be held before this court. The hearing will take place in the

Supreme Court Courtroom, State Capitol, Saint Paul, Minnesota, on Thursday, June 13,

2024, at 3:00 p.m. or immediately following the conclusion of the first public hearing

scheduled for 2:00 p.m. on that date, whichever occurs first. Any person or organization

who wishes to make a presentation at the hearing shall file a request to appear along with

one copy of the material to be presented with the Clerk of the Appellate Courts, using the

appellate courts' e-filing application, E-MACS, if required to do so. See Minn. R. Civ.

App. P. 125.01(a). All requests and accompanying materials shall be filed so as to be

received by the Clerk's office no later than Monday, April 29, 2024.
