What's New?

New Interface

A new interface will help users more easily navigate MGA, and seamlessly directs users to court records and documents.

Improved Search Display and Functionality

A new search display provides more information with initial search results, including any disposition and Level of Sentence, and allows users to find cases more quickly and without clicking multiple party results. Advanced search options and search filters will help users more quickly find the information they need.

The search results page changed and of this new interface page helps MGA users navigate and find court records and documents.
