We understand this schedule needs to be incorporated in a prepared order that must include Findings of Fact, Conclusions of Law, Order for Judgment and Judgment and Decree and that those papers still need to be submitted to the Court before our action is complete.

Attorney _____ (initial here) _____ shall prepare the Order **and** submit to court within **fourteen (14) days or if the time before our next hearing is less than 14 days, at least 5 days before the next scheduled hearing.**

The attorneys and the parties shall sign the stipulated Order and shall submit the same to the court within 30 days. If the county has an interest in child support, the proposed order shall be submitted to them for signed approval before submitting it to the court.

PRO SE Party's: We understand the information on this agreement will be used to complete a Stipulated Findings of Fact, Conclusions of Law, and Order for Judgment to be submitted to the Court within 14 days or 5 days before the next scheduled hearing.

General Agreements:

___ Before either party may bring a motion for parenting time assistance; the parties must attempt to resolve their disputes by **1) On their own OR 2) With assistance of a neutral third party (PTE, mediation, etc)** and share equally in all expenses unless specifically stipulated. They must further negotiate in good faith, and file a summary of their attempts to resolve the disputes with any future court documents

___ If either parent desires to move outside the school district or out of the state, or either parent believes that such a move will require a change in the parenting schedule, the parents agree to discuss how the child (ren) will be affected by changes in residence and to *renegotiate* the parenting schedule, in the best interest of the child (ren). The parents shall use one or a combination of the following process.

***PTE, *Custody Study, *Modify themselves by mutual agreement, *Parenting Consultant, *Mediation**

___ Parents agree to continue to cooperate and co-parent the children.

___ Parent agree to use one of the following methods of communications: Please circle all that may apply.

***Our Family Wizard, * Communication Notebook, *Emails, *Telephone/Voicemail/Text Message**

___ Parents will exchange and have all current contact information (cell phone, emails, landline phone)

___ **All** involved parties will refrain from any rude or inappropriate communication.

___ Parents will give a minimum of **1 week** notice for any change in agreed scheduled, excluding emergencies.

___ Orders prohibiting the parties from any contact may be amended to allow for contact /communication between the parties regarding the children. You will need to see Court Administration/your attorney, to complete this process.

___ Notify the other parent as soon as humanly possible regarding emergency medical/dental treatment

___ All other written or oral evaluations, notices, information will be exchanged to include school and all school related and extra curricular activities, medical and dental

___ Each parent will make direct contact with school, teachers, medical, dental and all other providers for the child (ren)

MOM / DAD shall submit to random drug / alcohol testing. The requesting party will pay the fee if any.

MOM / DAD will participate, complete and follow all treatment plans as noted.
