Use this form if:

- You requested a hearing on your citation; AND
- Your case was heard by a referee; AND
- You would like a judge to review the referee's decision; AND
- You are making this request within 10 days of receiving notice of the referee's decision.

NOTE: You also have the right to appeal directly to the Minnesota Court of Appeals, either before or after a judge reviews the referee's findings and order. Appealing to the Minnesota Court of Appeals is a more complicated process. See www.mncourts.gov/CourtOfAppeals/COAHelpTopics.aspx for more information on the Court of Appeals and how to file an appeal.

If you have any question regarding your legal rights and remedies, you should seek legal advice. Step-by-Step Instructions

- 1. Fill out the attached *Notice of Review of a Referee's Findings & Order*.
- 2. Contact the court to receive a hearing date and time for the review. You will need it to fill out the Notice of Review form. You can contact by phone at 612-348-2040, or in person at any Hennepin court location.
- 3. Write the hearing information into the Notice of Review form.
- 4. Make two copies of the completed Notice of Review form. The original is for the court (see #7 below). One copy is for you.
- 5. The second copy must be mailed or hand-delivered to the city prosecutor for your case. (See attached list of city prosecutors.) You can do this, or you can ask someone else over the age of 18 to do this for you.
- 6. After the copy of the Notice of Review has been mailed/delivered, the person who mailed/delivered it must complete the attached Proof of Service.
- 7. File the original Notice of Review (the one you filled out not a copy) and the completed Proof of Service at least seven (7) calendar days before the hearing. You can file these documents in one of these ways:
 - in person at any Hennepin court location (see attached list of courthouses)
 - mail to the Violations Bureau at 300 South Sixth Street, Minneapolis, MN 55487.
 - eFile using the eFile & Serve system.

Your case will not be on the calendar if you don't file on time.

8. Do not be late for your hearing. Plan on arriving early because you will have to go through weapons screening. If you get to the courtroom even a few minutes late, your motion may be denied if your case was already heard and you were not there.
