



eFS System Update: Enhancements Due to 2015 Minnesota Court Rule Amendments

Overview

In April the Minnesota Supreme Court [adopted amendments](#) to the Minnesota Rules of Court that provide a timeline for the statewide expansion of eFile and eServe (eFS) to all 87 Minnesota counties:

- **July 1, 2015:** Use of eFS is mandatory for attorneys, government agencies, and guardians ad litem in all court cases filed in the 11 eCourtMN pilot counties (Cass, Clay, Cook, Dakota, Faribault, Hennepin, Kandiyohi, Lake, Morrison, Ramsey, and Washington).
- **End of 2015:** eFS will be available in the other 76 counties. Use of eFS in those counties will be voluntary, and more information will be available in the coming months.
- **July 1, 2016:** Use of eFS is mandatory for attorneys, government agencies, and guardians ad litem in all district courts statewide.

Other court filers, such as self-represented litigants and medical examiners, may begin using eFS in the 11 pilot counties on July 1, 2015, and in other counties as it becomes available. Court Rules require that once a filer has used eFS to file a document, he or she must use eFS for all future filings in that case.


Highlight of Changes

Additional Rejection Reason

Amendments to the Minn. R. Civ. P. 5.04 add an additional rejection reason: Discovery Submission not authorized by Court.

Certifications Checkbox

Filers will see a pop-up appear prior to submitting documents for eFiling. Filers must check the box and select Agree to submit the envelope for processing.



Independent User Registration

Filers may now register as an independent user, without the need to create a firm.

This option is recommended for use by:

- Filers identifying themselves as Self-Represented Litigants.
- Filers not associated with a law firm, government agency, or organization.
- Filers that intend to file in a single case or case type but not as an attorney.

Service Before Review

Due to the changes to Rule of Civil Procedure 5.02(c), service is effective upon successful transmission of the document to eFS. When filers eFile and eServe documents together, service will no longer await acceptance by the court, but will transmit immediately.

Service recipients will receive an email notification with a link to the document immediately upon successful transmission to eFS by the filing party. If the filing is later rejected by the court, the filer and service recipient will receive a rejection email notification.
