Instructions for Motion to Withdraw a Plea of Guilty to a Citation

Use this information for payable citations filed in Ramsey County

- 1. Fill out the attached Notice of Motion and Motion to Withdraw a Plea of Guilty to a Citation.
 - If you do not have your court file number, you can find it at www.mncourts.gov. You can look up the court file number by citation number or by your name. If you need further assistance please call 651-281-3219 (metro) or 1-800-657-3611.
- 2. Make two copies of the completed Notice of Motion and Motion paperwork. One copy is for you to keep, and the other copy must be served on the prosecutor.
- 3. Have a third party (not you) who is 18 years or older and not involved in the case, mail a copy of the motion paperwork to the prosecuting attorney. The addresses are listed on the last page. The prosecuting attorney is based on the city where your citation was issued.
 - The envelope should be mailed using first class mail. It cannot be mailed on a legal holiday.
- 4. The person who mailed the copy of the Notice of Motion and Motion paperwork must complete the Proof of Service. This must be completed after the envelope has been mailed.
- 5. File the <u>original Notice</u> of Motion and Motion paperwork, and the <u>original Proof</u> of Service with Ramsey District Court. You can mail in the original documents or drop them off at the public service counter.
