- Each party pays \$300 for the first 3-hour ENE session and \$100 per hour for any additional time, except that parties who are granted *IFP* status will pay \$150 for the first 3-hour ENE session and \$50 per hour for any additional time. There are separate fees assessed for SENE and FENE.
