Each party's rate is individually determined. If a party is represented by counsel, other than pro bono or legal aid counsel, the party will be charged **one-half the hourly rate** charged by that party's counsel, per hour FENE. If the party is represented by more than one attorney, the party shall pay **one-half the average hourly rate** of all the attorneys, per hour for FENE. This means that the party will be charged the hourly rate * 3 hours at a minimum, for the initial 3-hour FENE session, and pay hourly after that. [Attorney's normal hourly rate * ½ * 3 hours = fee for initial session. Or Average of Party's Attorneys' normal hourly rate * ½ * 3 hours = fee for initial session.]
