ORDER RE: PENDING

Whereas, Edward Lynch, Chief Judge of the First Judicial District has Ordered the consolidation of cases on the attached list for the sole purpose of resolving matters related to the source code; and

Whereas, certain of these consolidated cases may assert issues and challenges other than to the source code, which may result in decision(s) which will lead to dismissal or other disposition not requiring further handling by the courts; and

Whereas, the consolidation of these cases is intended to solely decide the source code issue, and to decide the source code as the sole remaining pretrial issue to be resolved in these cases;

THEREFORE, IT IS ORDERED AS FOLLOWS:

1. In all cases on the attached lists, counsel for each of the parties shall forthwith confer and identify for hearing all remaining contested issue(s); except source code. This requirement of identification and hearing of non-source code issues shall apply to existing cases and shall continue to apply to all new criminal and implied consent cases which raise the source code issue in addition to other pretrial issues and are commenced as of February 16, 2010.
2. Counsel are ordered to have all such non source code issues calendared and heard before April 19, 2010. These hearings are to be conducted in the County of origin for each case. Continuances will not be permitted. Failure to schedule and complete

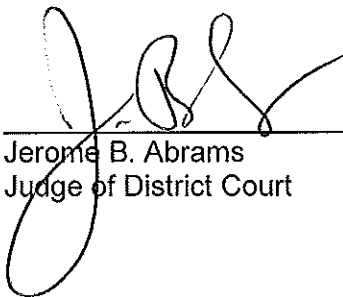

hearings of contested pretrial issues other than source code by April 19, 2010 will result in dismissal of all such issues; except for good cause shown.
