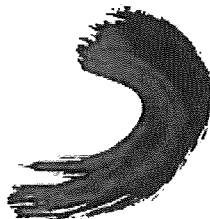

AGREEMENT (the "Agreement") made as of the 25th day of June 2018 by and between Sony Music Entertainment, 25 Madison Avenue, New York, NY 10010-8601 (hereinafter referred to as "Sony") and The Estate of Prince Rogers Nelson p/k/a "Prince" ("Artist") and its affiliated entities including NPG Records, Inc. through the authority of Comerica Bank & Trust N.A., P.O. Box 75000, Detroit, Michigan 48275-2393 Attn: Andrea Bruce (hereinafter referred to as "you", "your", the "Estate" or "PRN"), acting in its fiduciary capacity as the personal representative of PRN ("Personal Representative") appointed by the Carver County, Minnesota, District Court (the "Court").

WHEREAS, Artist died in his Carver County, Minnesota residence on April 21, 2016, and Personal Representative was duly appointed by the Court as the personal representative of the Estate in the probate matter pending in Carver County District Court File No. 10-PR-16-46;

WHEREAS, the duties and powers of the Personal Representative are subject to and governed by orders issued by the Court, including but not limited to, the Court order dated March 21, 2017 giving the Personal Representative authority to hire advisors for the Estate and enter into transactions on behalf of the Estate ("Order"). Sony acknowledges and agrees that the power of the Personal Representative is limited by laws applicable to its appointment by the Court as well as orders of Court including the Order ("Court Limitations"). All references to Personal Representative herein shall include any successor personal representative of the Estate, or at the closing of the Estate, the persons with authority to bind the Estate. To the extent there is ambiguity regarding whether and to what extent this Agreement is impacted by the Court Limitations, the parties to this Agreement shall meet and negotiate in good faith to prepare a written amendment evidencing their agreement regarding any required modifications to this Agreement, provided that, if necessary, the parties shall submit such amendment to the Court for its approval. Sony acknowledges that Personal Representative, and any of its successors and/or assignees, are limited in their knowledge of the Estate to the information it has learned through the due diligence process which is ongoing as of the Start Date of this Agreement and does not have the knowledge that Artist possessed at the time of his death.

WHEREAS, For the duration of the appointment as Personal Representative and subject to the Court Limitations, Personal Representative controls the assets, rights, obligations, and finances previously owned by Artist that comprise the Estate. In furtherance of its duty to preserve and protect the assets of the Estate, Personal Representative now wishes to enter into this Agreement with Sony on behalf of the Estate.
