The above-entitled matter came before the undersigned on \_\_\_\_\_ pursuant to the stipulation regarding sharing confidential information with the Estate of Alfred Frank Alonzo Jackson, Jr., between Comerica Bank & Trust, N.A., as Personal Representative (“Personal Representative”) of the Estate of Prince Rogers Nelson (“Prince Estate”), on the one hand, and Timothy J. Murphy, as Administrator Pendente Lite (“Murphy”) of the Estate of Alfred Frank Alonzo Jackson, Jr. (“Jackson Estate”), on the other hand.

Based on the stipulation and all the files, records, and proceedings herein, the Court hereby makes the following:

**ORDER**

1. Effective upon Murphy executing a non-disclosure agreement in the form provided by the Personal Representative, the Personal Representative shall share confidential information related to the Prince Estate with Murphy on the same terms as, and subject to the restrictions, limitations, and rights applicable to, Primary Wave Music Fund I, LP as set forth in the Court’s Order dated March 26, 2020.

2. Upon the appointment of a successor to Murphy as authorized representative of the Jackson Estate, that successor, the Personal Representative, or any other interested person may seek to modify the application of protocols set by the Court, including those set forth in the Order dated March 26, 2020, as it relates to the sharing of information with authorized representatives of the Jackson Estate.
