DESIGNATION OF SELECT USERS, DISTRICT COURT LOCATIONS AND COURT CASES

SUBJECT TO VOLUNTARY E-FILING AND E-SERVICE COURT RULES

Pursuant to Minn. Gen. R. Prac. 14.01(b)(4), the state court administrator has the authority to designate Select Users, district court locations and court cases for the purposes of voluntary E-Filing and E-Service. Therefore, the state court administrator authorizes the following:

- 1. <u>Select Users</u>. For the purposes of voluntary e-Filing and e-Service under Minn. Gen. R. Prac. 14.01(b)(4), a "Select User" includes the following appearing or submitting documents in a case (*see* Minn. Gen. R. Prac. 14.01(a)(10)):
 - a. Attorney;
 - b. Government agency (including sheriffs); and
 - c. Guardian ad litem.
- 2. <u>Self-Represented Litigants</u>. A self-represented litigant may voluntarily E-File and E-Serve in any district court location where voluntary E-Filing and E-Service is authorized herein, pursuant to Minn. Gen. R. Prac. 14.01(b)(5).
- 3. <u>Non-Party Participants.</u> Individuals who are not Select Users or self-represented litigants but who need to submit documents to the court for filing may voluntarily E-File and E-Serve in any district court location where voluntary E-Filing and E-Service is authorized herein, pursuant to Minn. Gen. R. Prac. 14.01(b)(6).

4. <u>District Court Locations.</u> The following district court locations are subject to the voluntary E-Filing and E-Service provisions of Minn. Gen. R. Prac. 14.01(b)(4), effective on the corresponding effective date:

- 5. <u>Court Cases.</u> Select Users authorized herein may voluntarily E-File and E-Serve in all court cases in the district court locations as designated herein, unless otherwise provided in Minn. Gen. R. Prac. 14.01.
- 6. End Date. The last effective date of this designation is June 30, 2016. Effective July 1, 2016, E-Filing and E-Service is mandatory throughout the State of Minnesota pursuant to Minn. R. Gen. Prac. 14.01(b)(1).
