I understand:/Ngang uwa weweiti pwe:

1. I am charged with committing the offense(s) described in the complaint, citation, or ticket. Ngang uwa tipis ren ekkei sakkun tipis mei affat me non taropwen tichchikin pwarata met fofforongaw uwa atai, pwan met taropwen annukun unteng ika uwou tarakku.
2. The maximum sentence for a gross misdemeanor offense is a fine of \$3,000 and applicable surcharges, one year in jail, or both. Asanapan aukukun tipisin an emon epwe puratiw tipis kukkun, mei tongeni pakking ren \$3,000 chana pwan met epwe pwan pacheta, ika eu ier non kanapus, ika ir me ruu.
3. I have the right to be represented by an attorney at all times, including police line-up or during police questioning. Mei wor rei pwuung an epwe wor emon Sou-Annuk epwe tupuni ei non meininis ekkewe tettenin Kapung, pwan pachenong epwe wor police repwe aninnis non fansoun an police kapas eis.
4. An attorney will be appointed to represent me if I cannot afford to pay for an attorney. Epwe wor emon Sou-Annuk epwe kefinita an epwe anisi ei, ika use tongeni moni emon Sou-Annuk epwe anisi ei.

5. I do not have to say anything about the case. I do not have to answer questions from anyone about the case.
Esap wor met upwe pwan apasa usun ei kapung. Usap pwan tongeni ai upwe upwe ponuweni kapas eis seni emon fan itan ei kapung.
6. Anything I say may be used against me in Court.
Ese nifinifin met upwe apasa mei tongeni epwe uu ngeni ei non Kapung.
7. I can speak to an attorney before my next Court appearance, and I will be given enough time before my next Court date to obtain an attorney.

8. I can have a jury trial or a trial by a judge without a jury.

9. I can tell the judge today what I think should be done about bail or my release from custody.

10. I can be charged with a crime if I fail to appear in Court when I am told or notified of a Court date, and the punishment for failure to appear can include jail, a fine, or both.
