I understand:/Ngang mei weweiti pwe:

1. I am charged with committing the offense(s) described in the complaint, citation, or ticket. Ngang uwa tipis ren ekkei sakkun tipis mei affat me non taropwen tichchikin pwarata met fofforungaw uwa atai, pwan met taropwen annukun unteng ika uwou tarakku.
2. The maximum sentence for a petty misdemeanor offense is a fine of \$300.00 and applicable surcharges. Asanapan aukukun tipisin an emon epwe puratiw tipis kukkun, mei tongeni pakking ren \$300 chana pwan met epwe pwan pacheta.
3. I have the right to be represented by an attorney at all stages of the proceedings. However, Minnesota law states I must hire my own attorney for a petty misdemeanor charge. Mei wor rei pwuung an epwe wor emon Sou-Annuk epwe tupuni ei non meinisin ekkewe tettenin Kapung. 4. I have the following rights:/Mei wor rei ekkei Pwuungun Finata:
 - a. for the case to be continued for me to obtain or speak to an attorney. ren an eu Kapung epwe tongeni sopwosopwono fan itei, ai upwe tufichin kutta, ika porous ngeni emon Sou-Annuk.

- b. to a trial before a judge in which I am presumed innocent until proven guilty by the state beyond a reasonable doubt.
ren an emon Sou-Kapung epwe finata pwe ngang use tipis, esapw tongeni ponuweta tori met state epwe finata anongonong won met a pwisin finata anongonong won pisekin pwarata.
 - c. to remain silent at all times, including at trial. Anything I may testify to can be used against me in Court.
