- 7. Determining the persons entitled to distribution of the Estate and their respective interests.
- 8. Approving settlement of the Estate and:
 - Issuing a decree of distribution assigning the Estate to the persons entitled to the Estate.

OR

- Directing or approving the distribution of the Estate by the Personal Representative to the persons entitled to the Estate.
- 9. Granting such other relief as may be proper.
