**DECLARATION OF WILLIAM R. SKOLNICK**

1. My name is William R. Skolnick. I am an attorney licensed to practice law in the State of Minnesota.
2. I am the CEO of Skolnick & Joyce, P.A., and I had substantial involvement with the billing and legal representation in this matter.
3. Skolnick & Joyce, P.A. ("the Firm"), formerly represented Sharon, Norrine, and John Nelson ("SNJ") in the above entitled matter.
4. I make this declaration for the purposes of transmitting certain documents to the Court and in support of the Firm's Motion for an Attorneys' Lien pursuant to Minn. Stat. §§ 481.13 & 525.491.
5. On October 27, 2017, SNJ executed a retainer agreement with the Firm. Attached hereto as Exhibit 1 is a true and correct copy of that retainer agreement.
6. Exhibit 1 contains a provision concerning representation of L. Londell McMillan. Mr. McMillan never executed a retainer agreement with the Firm and the Firm did not represent him in connection with these matters.
7. From the period beginning on October 18, 2017, the Firm continuously provided legal services related to this matter to SNJ and billed SNJ on a monthly basis for those services.

8. Other than payment of the \$25,000 retainer, SNJ made no payments to the Firm for the legal services billed.
9. On numerous occasions, the Firm demanded payment of past due legal fees and costs, but no payment was made by SNJ.
10. On June 29, 2018, the Firm withdrew from representation of SNJ due to non-payment of the fees.
11. On August 27, 2018, the Firm perfected its attorneys' lien by serving a copy of its Notice of Attorneys' Lien upon Comerica Bank & Trust, N.A., the personal representative of the Estate of Prince Rogers Nelson. Attached hereto as Exhibit 2 is a true and correct copy of the August 27, 2018 Notice of Attorneys' Lien.
12. Attached hereto as Exhibit 3 is a true and correct copy of the affidavit of service upon counsel for the personal representative of the Estate.
13. Attached hereto as Exhibit 4 are true and correct copies of the redacted time and billing records detailing the work performed by the Firm on SNJ's behalf. Entries on the billing record correspond to the following individuals:
  - WRS is William R. Skolnick
  - ADJ is Amy D. Joyce
  - SMJ is Samuel M. Johnson
  - LCK is the designation for law clerk.
14. S&J sends invoices to its clients at the start of each month.
15. At no point did SNJ ever object to the amounts incurred on the invoices that were sent by the Firm.

16. I reviewed the original records and confirm that all work was actually performed and all costs were incurred for the benefit of SNJ and were necessary for the proper representation of SNJ. Charges for any unnecessary or duplicative work have been eliminated.

17. At present, SNJ owe the firm \$180,935.12, which is the claimed lien amount.


This letter states the agreement for the legal services Skolnick & Joyce, P.A. (“the Firm”) will provide to Sharon L. Nelson, Norrine P. Nelson and John R. Nelson as heirs to the estate of Prince Roger Nelson. In addition, the Firm will provide litigation services to Londell McMillan for any joint claims he shares with Sharon, Norrine and John. If the terms are acceptable, please obtain the signatures and return the original with the retainer fee referenced in paragraph 9.

1. Scope of Services for Sharon, Norrine and John. Sharon, Norrine and John have hired the Firm to give them legal advice, counsel and litigation services in regards to protecting claims as heirs of the Estate of Prince Roger Nelson (the “Estate”) and/or claims concerning the moving of music recordings from the vault at Paisley Park to California by Comerica Bank. By this Agreement, the Firm does not undertake or agree to represent any other persons or entities.

2. Scope of Services for Joint Claims with Londell McMillan. In the event that Londell McMillan has joint claims with Sharon, Norrine and John, the firm agrees to represent Londell, Sharon, Norrine and John jointly (if there are no conflicts of interest that would impair or prohibit such representation). Londell will be responsible for 25% of all fees and expenses owed to the firm on any such joint claims.

3. The Firm’s Obligations. The Firm will keep you informed of all developments and will send you copies of important letters and documents. The Firm will give you advice in advance if you have important decisions to make, will explain the legal issues involved and your options.

4. Your Obligations. The Firm expects you to work on your case, to answer the Firm’s calls and letters and supply complete and accurate information. The Firm also expects you to make timely payment of retainers, fees and expenses and to cooperate in all reasonable requests. The Firm understands that payment of fees and expenses owed by Sharon, Norrine and John may be delayed

until they receive a distribution from the Estate.

5. Legal Fees and Expenses. You have agreed to pay the Firm \$475.00 per hour for time spent working on your case by William R. Skolnick. To help keep your bill as low as possible, the Firm may use associates or legal assistants to help work on your matter. The hourly rates for such individuals are substantially less than that of Mr. Skolnick. You can expect to be billed for all time devoted to your matter, including phone calls and letters. You will also be billed for out-of-pocket expenses, including such things as court reporters, travel costs, filing fees, messengers and copying costs. The hourly rates for the lawyers in the Firm are:

a. William R. Skolnick	Partner	\$475
b. Amy D. Joyce	Partner	\$350
c. Andrew H. Bardwell	Partner	\$300
d. Samuel M. Johnson	Associate	\$225
e. Law clerks		\$100

The hourly charges for lawyers may change. However, the Firm will give you written notice 30 days prior to any changes in the hourly rates.

6. Travel and Lodging. Partners fly first class in the U.S. and associates fly coach. Travel time is charged at the full rate described above – not to exceed actual time.

7. Billing. The Firm will send you a monthly statement for legal services and expenses. Your statement is due upon receipt.

8. Termination and Withdrawal. You have the right to terminate the Firm's services and this Agreement at any time. You will, however, still owe the Firm any money due at the time you give notice of that decision. The Firm has the right to withdraw from representing you if a) you do not pay any statement on time; b) you insist upon pursuing an objective that is imprudent; c) you make representation unreasonably difficult or unethical; d) you fail to disclose information after being asked to do so or disclose false information; or e) other good cause for withdrawal exists. The Firm does not give up the right to withdraw even where the Firm continues to represent you after non-payment or other event permitting withdrawal.

9. No Guarantees. It is agreed that the Firm has made no guarantees concerning the outcome in this matter and that you are obligated to pay fees and costs regardless of the outcome.

10. Retainer. You have agreed to pay the Firm a retainer fee of \$25,000.00. This retainer fee will be deposited in a trust account. The retainer fee will be used to pay out-of-pocket expenses and legal fees as they come due.

11. Arbitration. All parties agree that any disputes involving fees, costs, billing, claims of professional negligence, malpractice, and breach of ethical or fiduciary duties the parties hereto arising under this agreement or as a result of any legal services performed by The Firm with respect thereto shall be submitted to binding arbitration pursuant to the rules of the American Arbitration Association. All arbitration hearings and proceedings shall be held in Hennepin County, Minnesota.
