RANDALL W. SAYERS, being first duly sworn upon oath, deposes and states as follows:

- 1. I am a partner at Hansen, Dordell, Bradt, Odlaug, and Bradt, PLLP ("Claimant"), and I make this affidavit in support of Claimant's application for a lien for attorney's fees.
- 2. Starting on November 8, 2016, Claimant represented Sharon Nelson, Norrine Nelson, and John Nelson ("SNJ") in matters related to the Estate of Prince Rogers Nelson. Claimant and SNJ had a written Representation Agreement for the payment of fees for Claimant's legal services. A true and correct copy of this Representation Agreement is attached as Exhibit 1.
- 3. During all relevant times I was the supervising attorney for Claimant's representation of SNJ.

- 4. During the representation of SNJ, Claimant provided legal services and incurred fees on behalf of SNJ, which SNJ are responsible to pay by the terms of the Representation Agreement. Claimant sent monthly invoices to SNJ detailing the work performed and expenses incurred on their behalf; SNJ never made any objection to any of these invoices. After all payment from SNJ, these invoices totaled \$266,108.43.
- 5. I reviewed all the invoices before they were sent to SNJ, and all of the work performed and expenses incurred were reasonable for SNJ's representation. The hourly rates charged by Claimant were reasonable given the amount of work and the nature and complexity of the issues involved. A true and correct summary of the invoices is attached as Exhibit 2.
- Claimant has not been paid by SNJ or from the Estate for any of the work performed 6. or expenses incurred on behalf of SNJ which are claimed herein. Claimant has timely filed and served a Notice of Intent to Claim Attorney's Lien on SNJ and the Personal Representative. Claimant also filed a UCC Financing Statement with the Minnesota Secretary of State. At true and correct copy of this filing with amendment is attached as Exhibit 3.

#### FEE RETAINER AGREEMENT

This Fee Retainer Agreement acknowledges the fee arrangement by which Hansen Dordell will represent Sharon Nelson, Norrine P. There is a minimum charge of one-tenth hour for any service. Monthly statements will be mailed to you during the course of our work on this matter. All billings are due and payable within thirty (30) days of receipt of the statement; provided that Hansen Dordell, in its discretion, may permit payment to be deferred until Client's receipt of funds from the Estate.

In addition to legal fees, we will be entitled to reimbursement for costs and disbursements incurred and advanced (in our discretion) on your behalf. Each bill will also include any out-of-pocket expenses incurred on your behalf. Examples of these expenses are long-distance telephone charges, postage, photocopying, messenger service, etc. We will not incur any expenses in excess of \$400 without your prior consent. We retain the right to require payment of costs in advance.

We have not required a retainer from you. We reserve the right to request a retainer deposit in the future. Any amount deposited as a retainer will serve as a source of payment of our monthly statements, with the stated amount to be deducted from the retainer on the date the statement has been mailed to you. Under rules established by the Minnesota Supreme Court, interest earned on the retainer trust account will be paid to the Minnesota Lawyers Trust Account Board. Any unused portion of the retainer will be returned to you upon the completion of the services to be rendered, or sooner, if our services terminate beforehand.

You shall at all times have the right to terminate our services upon written notice to that effect. We shall at all times have the right to terminate our services upon written notice to that effect if you fail to cooperate with us in any reasonable request, fail to make the payments required under this Retainer Agreement, or if ethical considerations under the Rules of Professional Conduct require us to withdraw.

Hansen Dordell will be representing all of you. Whenever a firm represents more than one person there is a potential for a conflict of interest. Information that any of you gives to us cannot and will not be kept by us from the others. However, it is still possible for the firm to represent all of you. Following is a more detailed discussion of this issue and a consent by each of you so we can represent all of you.

Legal ethics require that you be given an explanation of "dual representation" and that we obtain your consent before we undertake dual representation. Dual representation occurs when a lawyer represents two or more clients at the same time on the same matter. You may have differing interests, if not potential or actual conflicts of interest. These differing interests may affect the lawyer's ability to serve each of you with independent legal advice. If each of you had a separate lawyer, each of you would have an "advocate" and would receive totally independent advice.

On the other hand, in amicable circumstances, where each of you apparently shares the same objectives, the use of one lawyer or firm can be beneficial, and, of course, produce cost savings and efficiencies.

With regard to client confidences, each of you should realize that the lawyer or law firm cannot keep information confidential between you, since the lawyer is serving all of you. Therefore, by requesting dual representation, each of you is authorizing the lawyer and law firm to reveal information you give to the lawyer and law firm to the others.
