

ORDER REGARDING CAMPER REQUEST FOR GENETIC TESTING

The above entitled matter came on before the Honorable Kevin W. Eide after the Court's receipt of two submissions filed by Shirley Camper on September 27, 2019. Those submissions seek genetic testing for Ms. Camper's daughter, Tamika Joy H. Camper, to determine whether Tomik & Decedent is her daughter's father.

Now, based on the file and proceedings herein, the Court makes the following:

FINDINGS OF FACT & CONCLUSIONS OF LAW

- 1. Among other things, the Protocol for Genetic Testing previously ordered in this proceeding requires that a party claiming a genetic relationship to the Decedent that may give rise to heirship file an affidavit setting forth the facts that establish the reasonable possibility of the existence of such relationship.
- 2. Ms. Camper's submissions do not allege she had sexual contact with Decedent at any time.
- 3. As a result, Ms. Camper has not provided facts sufficient to establish the reasonable possibility that the Decedent is her daughter's genetic father. For example, Ms. Camper has not: (a) claimed that her daughter is the child of the Decedent due to the presumption of paternity under the Minnesota Parentage Act; (b) alleged a relationship between the Decedent and her daughter during his lifetime; or (c) provided an affidavit indicating that

she had a sexual relationship with the Decedent which resulted in her daughter's conception.

4. Based upon the information provided, Ms. Camper has not established a *prima facie* showing that her daughter is the child of the Decedent.

ORDER

- 1. Ms. Camper's daughter is not entitled to genetic testing.
- 2. Any other motions set forth in Ms. Camper's submissions filed September 27, 2019 are respectfully DENIED.


