**ORDER GRANTING MOTION TO  
 DISMISS AMELIA WODEHOUSE'S  
 COMPLAINTS**

---

The above-entitled matter came before the undersigned for a hearing on August 27, 2021, pursuant to Comerica Bank & Trust, N.A.'s Motion to Dismiss Amelia Wodehouse's complaints. Appearances were as noted in the record. Based on the Motion and the arguments at the hearing,

**IT IS HEREBY ORDERED:**

1. Plaintiff's three complaints, all dated June 24, 2021, filed against the Estate of Prince Rogers Nelson ("Estate"), are barred under Minnesota's Uniform Probate Code.
2. To the extent that Plaintiff is asserting that she is a beneficiary of the Estate as a result of a "Digital Will Contract," she failed to timely seek to vacate the Court's May 18, 2017 Order Determining Intestacy, Heirship & McMillan Matters. Minn. Stat. § 524.3-412(3)(iii). Further, she has not offered any credible evidence to support a finding that she would be a beneficiary such as to give the Court good cause to review its May 18, 2017 Order.
3. To the extent Plaintiff is attempting to assert claims as a creditor of the Estate, her claims are time-barred. Plaintiff's complaints reference both a contract from 1996 and conduct from 2017 as giving rise to her claims. In the case of the former, her claims are barred by Minn. Stat. § 524.3-803(a). In the case of the latter, her claims are barred by Minn. Stat. § 524.3-803(b).

4. Accordingly, Comerica Bank & Trust, N.A.'s Motion is GRANTED, and all claims set forth in Plaintiff's three complaints are hereby dismissed with prejudice.

5. The Estate's motion to dismiss Plaintiff's Complaints was filed and served on July 26, 2021. Plaintiff's response was due no later than August 12, 2021. In considering this motion, the Court considered all submissions by the Plaintiff through August 17, 2021. Plaintiff's August 17, 2021 submissions include a document entitled Memorandum which appeared to address the Estate's motion. All documents filed after August 17, 2021 are determined to be repetitive, irrelevant and/or untimely. As the Court has granted the motion to dismiss Plaintiff's complaints, the Plaintiff shall file no further documents with the Carver County District Court related to any same or similar claims except as they may relate to an appeal of this Court's Order.

LET JUDGMENT BE ENTERED ACCORDINGLY
