**ORDER GRANTING MOTION TO  
DISMISS CASSANDRA BOYD'S  
LETTERS AND AFFIDAVITS  
REQUESTING RELIEF**

---

The above-entitled matter came before the undersigned for a hearing on October 15, 2021, pursuant to Comerica Bank & Trust, N.A.'s Motion to Dismiss Cassandra Boyd's (Plaintiff's) letters and accompanying affidavits. Appearances were as noted in the record. Based on the Motion and the arguments at the hearing, **IT IS HEREBY ORDERED:**

1. The relief requested in Plaintiff's letters and affidavits filed on August 18, 2021 and September 2, 2021 against the Estate of Prince Rogers Nelson ("Estate"), is barred under Minnesota's Uniform Probate Code.

2. Plaintiff asserts that she is the spouse of Prince Rogers Nelson, but she failed to timely seek to vacate the Court's May 18, 2017 Order Determining Intestacy, Heirship & McMillan Matters. Minn. Stat. § 524.3-412(3)(iii). As such, her claim to be recognized as a spouse of the decedent or heir of the Estate is time-barred.

3. Plaintiff makes specific requests for relief, all based on her alleged status as an heir of the Estate. Plaintiff requests that the Court decline to close the probate for the Estate, rescind all Estate contracts and deals, and that she receive sole possession and ownership of Estate assets. Because Plaintiff's claim that she is an heir or interested person is time-barred, her requests for relief are denied.

4. Plaintiff's remaining requests, related to protection of her identity and restraining orders, are not properly sought in this forum, and are therefore denied

5. Accordingly, Comerica Bank & Trust, N.A.'s Motion is GRANTED, and all claims set forth in Plaintiff's letters and affidavits are hereby dismissed with prejudice.

6. As the Court has granted the motion to dismiss Plaintiff's complaints, the Plaintiff shall file no further documents with the Carver County District Court related to any same or similar claims except as they may relate to an appeal of this Court's Order.

#### MEMORANDUM

Ms. Boyd claims that she was married to Prince Rogers Nelson in February, 2008 in Chattanooga, Tennessee. She has made no effort to call or go to the counties in and around Chattanooga to locate a marriage certificate. She has, instead, waited. She claims to have made attempts to contact some of the Heirs of the Estate, specifically Tyka Nelson. She claims to have waited for a communication from attorney Kenneth Abdo and, not hearing from him, finally to have made an attempt to contact him. However, her failure to attempt to locate a marriage certificate is inexplicable.

With all due respect for Ms. Boyd, the likely explanation is that she suffers from a mental illness. This would explain her unsupportable claims, her inability to look for a marriage certificate, her rambling 103 page affidavit, and the uncorroborated claims of relationships with a whole host of celebrities. that she is outright lying about her claims and she knows that, if she were to look for a marriage certificate, there is none to be found. If that is the case, she has wasted significant resources of the Estate.
