Based upon the confidential nature of the contents of the unredacted version of the Response, Boyarski Declaration, and Sandler Steinert Declaration, as well as Exhibit E to the Cassioppi Declaration, they may be filed and kept under seal until further order of this Court. The information qualifies as confidential commercial information under Minn. R. Civ. P. 26.03(a)(7), and there is no historical right of access to the information under the test articulated in *Minneapolis Star & Tribune Co. v. Schumacher*, 392 N.W.2d 197 (Minn. 1986).
