**ALFRED JACKSON, OMARR BAKER,

ORDER FINANCIAL VALUATION  
DOCUMENTATION**

Alfred Jackson, Omarr Baker, and Tyka Nelson ("The Heirs") bring this request before the Court by and through their attorneys. Since the PR has stated that it cannot or will not provide certain financial models, valuation documents and other business documents with the Heirs. The Heirs request a minimum of \$100,000 to be paid by the estate to designated counsel for the heirs to collectively retain financial and business experts to prepare and create asset financial models of detailed projected cash flows for the Estates Recorded Music, Publishing Catalog, Name and Likeness, Merchandizing, Real Estate Development, Film and Television projects, Theatrical Performances and as well as the overall financial performance of the Estate. The Heirs also request every contract that correlates with the revenue or expenses of the cash projection except those specifically excluded by the court. This information will (i) allow the Heirs to better replicate and confirm the cash flow statements provided by the PR on May 1<sup>st</sup>, (ii) give the heirs a better understanding of the current PR transition plan, (iii) align the Heirs and the PR with a common expectation in terms of distributing their inheritance, (iv) assist them in deciding on and directing

potential future business ventures, and prepare them for the eventual responsibility of managing the Estate once it closes.
