JOINT STIPULATION TO RECORD

TO: The Honorable Peter Cahill, Judge of District Court, Hennepin County Courthouse, Hennepin County Government Center, 300 South sixth Street, Minneapolis, MN 55487.

On October 24, 2022, Defendant Thao waived his right to a jury trial and agreed to a court trial on stipulated evidence under Minn. R. Crim. P. 26.01, subd. 3. The parties have reached agreement on the record for the stipulated evidence trial, which is set forth in the attached Exhibit List. The records and exhibits set forth in the attached exhibit list were provided to the Court and Counsel for Defendant on flash drives on Wednesday, November 9, 2022. The parties also agree that:

- 1) Some of the exhibits or portions of them are not directly relevant to the trial of Defendant Thao and the parties will not cite to those exhibits or portions in their proposed findings of fact and written summations.
- 2) Some of the exhibits from the state and federal trials were originally offered for illustrative purposes only, which would be reflected in the transcript of the trial when the exhibit was referenced. Those trial exhibits should be used for illustrative purposes only in this trial.

- 3) The transcript of the BCA interview of Defendant Thao (State's Supplemental Exhibit 22) is offered only as an illustrative exhibit, consistent with the typical use of transcripts as court exhibits only in a jury trial.
- 4) The parties intend to cite to the exhibits, consistent with the name of the file on the flash drive containing them, as follows:

"Chauvin Tr. ___" for the pages of the State v. Chauvin trial transcript.

"Chauvin Ex. ___" for the exhibits in the State v. Chauvin trial

"Fed. Tr. ___" for the pages of the U.S. v. Thao/Kueng/Lanc federal trial

"Fed. Gov't Ex. ___" for the government's exhibits in the federal trial

"Fed. Thao Ex. ___" for Thao's exhibits in the federal trial

"Fed. Kueng Ex. ___" for Kueng's exhibits in the federal trial


"Fed. Lane Ex. ___" for Lane's exhibits in the federal trial
