**DECLARATION OF LEITA WALKER  
IN SUPPORT OF MEDIA  
COALITION'S MOTION  
OBJECTING TO CLOSURE OF TRIAL  
TO THE PRESS AND PUBLIC**

Leita Walker declares as follows:

1. I am an attorney with Ballard Spahr LLP, representing intervenors American Public Media Group (which owns Minnesota Public Radio); Association of Minnesota Public Educational Radio Stations; The Associated Press; Cable News Network, Inc.; CBS Broadcasting Inc. (on behalf of WCCO-TV and CBS News); Court TV Media LLC; Fox/UTV Holdings, LLC (which owns KMSP-TV); Gannett Satellite Information Network, LLC (which publishes *USA Today*); Hubbard Broadcasting, Inc. (on behalf of its broadcast stations, KSTP-TV, WDIO-DT, KAAL, KOB, WNYT, WHEC-TV, and WTOP-FM); Minnesota Coalition on Government Information; Minnesota Spokesman-Recorder; NBCUniversal Media, LLC; Sahan Journal; Saint Paul Pioneer Press; The Silha Center for the Study of Media Ethics and Law; Star Tribune Media Company LLC; TEGNA Inc. (which owns KARE-TV); and WP Company LLC (which publishes *The Washington Post*) (collectively, the "Media Coalition").

2. I submit this Declaration in support of the Media Coalition's Motion Objecting to Closure of Trial to the Press and Public. This Declaration is based upon my personal knowledge and my review of the files, records, and proceedings in this action.

See my responses below.

Hi, [REDACTED], another question – I think you told me there are 7 seats for the media in the courtroom and 7 seats for the media in the overflow room. But the judge's order says there are 14 seats for the media in the overflow room. Can you clarify?

- I got this wrong and will be clarifying to everyone I've spoken to as soon as the pool camera people wrap up in here.
- Courtroom is 7 seats for media
- Overflow room actually has 24 seats as capacity, and yes you are correct – Judge Q's order says 14 will be reserved for media
- So media will have 14 seats reserved and, to your separate question, we're going to open any remaining public seats to media once the hearing starts at 9:00 a.m.

Can you also clarify – the judge's order prohibits photography in the hallway of the 10<sup>th</sup> floor but seems to allow it in the hallways on other floors, including the 16<sup>th</sup> floor. Can you confirm that?

- I am coordinating with pool camera/audio people now and can't analyze Judge Quaintance's orders in depth at the moment, but recording of any courthouse space including hallways is prohibited unless a specific order clarifies that it is allowed. By my quick read Section 8D of the below makes it clear that recording is not allowed in the spaces you're wondering about:
